Dear Lord John Russell.

We received a letter from the F. D. dated 22<sup>nd</sup> Aug<sup>r</sup> /60 suggesting that the Admiral on the best India station should with as little delay as possible send vessels to watch the Bahama Cays and also to cruise on the coasts of Cuba. The first object namely visiting the Cays which are British is unobjectionable, but if our ships of war cruise to the north of Cuba, we shall inevitably be brought into fresh difficulties with the United States. In the month of June 1858 these difficulties led to a letter from this office directing the officers of our cruisers to "respect the American flag in all cases, and under whatever circumstances of suspicion, until further orders".
